# FROM DISPLACEMENT TO REINTEGRATION AND DEVELOPMENT



During the peak of the 2014-2017 Daesh crisis, almost six million people were internally displaced across Iraq due to violent conflict. With the gradual improvement of the situation in most areas, millions had returned by December 2017, when the Prime Minister of Iraq declared victory over Islamic State in Iraq and Syria (ISIS) and recapturing of territory. Since 2018 the government has progressively consolidated and closed 65 camps in the country from the 91 which were created to shelter displaced families. Today 26 camps alongside more than 400 informal sites remain in Iraq. Both Internally Displaced Persons (IDPs) and returnees continue to face obstacles to successful return and post-return reintegration including:

A durable solution is achieved when the IDP no longer has any specific assistance and protection needs connected to their displacement and can enjoy their human rights without discrimination due to their displacement.

There are three pathways to a durable solution:

- Voluntary Return
- Local Reintegration
- Resettlement in 3rd location

Recognizing that the Government of Iraq is the primary duty bearer in enabling and promoting durable solutions to displacement, IOM works in close cooperation with authorities at the national, regional and local levels, providing technical support, material assistance, capacity building and support to the development of legislation and administrative processes to enhance access to solution pathways.
