

# DIRECTORY: ORGANIZATIONS OF PERSONS WITH DISABILITIES (OPDS) IN IRAQ

Persons with disabilities in Iraq have been disproportionately impacted by decades of war, armed conflict, terrorism, violence and economic hardship.<sup>1</sup> In 2019, the Committee on the Rights of Persons with Disabilities reported that Iraq has one of the largest populations of persons with disabilities in the world.<sup>2</sup> The disability rights movement slogan, 'nothing about us without us', urges humanitarian and development agencies to ensure the active participation of persons with disabilities in all steps of programming – from planning, to implementation, to evaluation.

This directory, detailing information on Organizations of persons with disabilities in Iraq (henceforth OPD directory), currently includes the contact details of 60 OPDs in Iraq across 18 governorates. Representatives of these OPDs estimate their collective membership to be approximately 180,000 persons with disabilities across Iraq. The OPD directory is made up of two sections:

## PART B: SUPPORTING INFORMATION

### TERMINOLOGY

This OPD directory uses the following terminology:

#### Persons with disabilities:

Disability is conceptualized using a rights-based approach, guided by the United Nations on the Rights of Persons with Disabilities (CRPD). Article 3 of the CRPD states that persons with disabilities include *“those who have long-term physical, mental, intellectual or sensory impairments which in interaction with various barriers may hinder their full and effective participation in society on an equal basis with others.”*

#### Organizations of persons with disabilities (OPDs):

The CRPD General Comment No. 7 describes OPDs as any organizations or associations led, directed, and governed by persons with disabilities that are entrenched, committed to, and fully respect the principles and rights recognized in the CRPD.<sup>3</sup> They are established predominantly with the aim of collectively acting, expressing, promoting, pursuing and/or defending the rights of persons with disabilities and bring a unique perspective to speak on their own behalf.

Organizations of persons with disabilities include umbrella and coalition organizations, impairment-specific organizations, formal organizations or informal groups, organizations including family members and/or relatives of persons with disabilities, self-advocacy groups, organizations of women with disabilities or organizations of children and youth with disabilities, among others.<sup>4</sup> CRPD General Comment No.7 notes OPDs “are not affiliated, in the majority of cases, to any political party and are independent from public authorities and any other non-governmental organizations of which they might be part/members of”.<sup>5</sup> In Iraq, however, OPDs are often affiliated with political parties and with government departments.

This OPD directory distinguishes between OPDs, which are organizations led, directed, and governed by persons with disabilities, and disability-specific civil society organizations (CSOs) and international organizations, which provide services and/or advocate on behalf of persons with disabilities, but do not have leadership primarily made up of persons with disabilities (and therefore are not viewed as OPDs).

### SIX TIPS ON FACILITATING ACCESSIBLE AND INCLUSIVE CONSULTATIONS WITH PERSONS WITH DISABILITIES AND THEIR REPRESENTATIVE GROUPS<sup>6</sup>

This section covers tips for facilitating accessible and inclusive consultations (including key informant interviews, community meetings, town hall meetings, focus group discussions, surveys, accessibility audits, and other participatory processes).

#### Tip 1: Identify and specifically invite persons with disabilities:

Many persons with disabilities are invisible in the community; therefore, organizations should make additional efforts to seek their input and feedback. Ways to identify persons with disabilities include:

- In non-camp settings: liaise with OPDs to identify and invite persons with disabilities to attend consultations. If OPDs do not exist in your area, identify persons with disabilities through community leaders, neighborhood committees, and women/men/youth committees to consult with.
- In camp settings: speak with Camp Coordination and Camp Management (CCCM) and persons with disabilities you have seen and ask them to share information about consultations with any other persons with disabilities they know of.
- Use a variety of communication methods to distribute invitations to consultations, such as flyers, announcements, videos, social media, and word of mouth.
- Ensure that the invitation clearly shows that persons with disabilities are invited to participate (alongside with persons without disabilities) in consultations, and that you will provide any additional requirements for persons with disabilities to attend by adding to the invitation: **People with disabilities are encouraged to attend.**

#### Tip 2: Ensure diversity within the group of persons with disabilities:

Where possible, ensure representation of persons with diverse disabilities in the consultations:

- In consultations that have both persons with and without disabilities: include at least one woman and one man with a disability, ideally with different types of disabilities.
- In consultation processes only with persons with disabilities: include persons with disabilities of all genders with a variety of disabilities including physical, psychosocial, intellectual, vision impairment and deaf persons.

Note: Women with disabilities are often more underrepresented in Iraq than men with disabilities (and are often more invisible in the community). Ways to ensure you hear directly from women with disabilities include: having female team members, specifically telling OPDs and partners that you want to hear from women with disabilities, and avoiding communicating with women with disabilities through a third person (parents, sisters, head of household).

**Tip 3: Find out whether assistance or support is required for persons to actively participate in the consultation:**

- Ensure the consultation organizer asks each person (through written or verbal invitations):
  - Do you require any additional support to enable you to participate in the consultation (for example, a support person or transport)?
  - If yes, please let the organizers know so that we can best meet your needs.
- Then, ensure these reasonable accommodations are organized, paid for and ready for the consultation.
- Provide the option for persons with disabilities to give feedback one on one, rather than attend the group consultation.

**Tip 4: Reduce physical barriers at consultation venue:**

Reducing physical barriers benefits persons with physical disabilities and vision impairments, along with pregnant persons, children, and older persons.

- Ask persons with disabilities about potential barriers they might face in accessing the consultation venue and what assistance they may require to attend. Develop a plan if the venue cannot be made accessible. Examples include temporary ramps, reducing the length of the consultation so that a person can return home to use their own toilet, or providing free transport options for persons with disabilities.
- To ensure accessibility, the venue should be easy to **reach, enter, circulate, and use.**

**Tip 5: Be proactive at the beginning of the consultation:**

- Ask persons with disabilities where they would like to be seated to best access the area and make use of lip-reading, sign interpreters, or language translation.
- Ask persons with disabilities if they would like to be paired with another person who could help in individual or group activities.
- Open the meeting by asking participants to speak slowly and clearly to facilitate translation, interpretation, and understanding for persons with intellectual disabilities, and for those who do not understand the spoken language well.

- If a person with a disability has brought along a support person or family member to assist them to participate, establish ground rules as to whether that support person can contribute their own experiences to the discussion or not and whether any additional ground rules around confidentiality are required.

**Tip 6: Encourage active participation**

- Some persons – with or without disabilities – might feel uncomfortable being in a big group, so make time for smaller group discussions.
- If an individual seems like they are not interested or quiet, encourage them to participate.
- Always treat participants with respect and ask their opinion in discussions.
- Encourage participants, translators, and interpreters to ask questions as the meeting progresses to ensure participants clearly understand discussions and that translations are correct.
- Ensure the venue is quiet to allow persons with vision impairment and those who have difficulty concentrating to participate and take part in the discussion.

**Tip 7: Use inclusive and respectful communication:**

- Present information in both visual and audio formats.
- Repeat key concepts and use practical demonstrations to help understanding.
- Use clear and non-offensive language. Only refer to someone's disability or impairment where it is directly relevant. If in doubt, ask them how they wish to be addressed.
- Talk directly to persons with disabilities rather than to persons who might be assisting them.
- Make sure only one person speaks at a time.
- If you are talking about experiences of persons with disabilities as part of the consultation: use the preferred terminology of the individual or group of people with disabilities. IOM Iraq has consulted with OPDs to confirm the correct general terms to use in English, Kurdish and Arabic:

## METHODOLOGY OF DEVELOPING THE OPD DIRECTORY

1. IOM Iraq disability inclusion staff identified and reviewed any lists of OPDs available and created a draft OPD mapping spreadsheet as a starting point (Version 1).<sup>7</sup>
2. In April 2020, IOM Iraq Community Stabilization Unit (CSU) field staff in nine governorates contacted select OPDs by phone (rather than in person, due to COVID-19-related movement restrictions) to validate and update the Version 1 mapping spreadsheet to check basic information and to gain consent for contact details to be used in mapping and a later directory. IOM Iraq disability inclusion staff entered collected information into an updated draft mapping spreadsheet, creating Version 2.
3. In June 2020, CSU field staff in nine governorates contacted the remaining OPDs by phone (due to movement restrictions) to validate and update the Version 2 mapping spreadsheet to check basic information and to gain consent for contact details to be used in mapping and a later directory.
  - o Information was then entered into updated draft mapping spreadsheet to create Version 3.
4. In July 2020, IOM Iraq started planning to carry out a rapid consultation with representatives of OPDs from 18 Governorates. Version 3 mapping was used to create a list of OPDs to contact for key informant interviews.
  - o The Iraqi Alliance of Disability Organizations (IADO) reviewed and endorsed the list (from the mapping) of OPDs for the consultation.
5. In October 2020, IOM Iraq carried out a rapid consultation with 53 OPDs and 15 disability-specific CSOs and government entities. The key informant interview semi-structured questionnaire contained 33 questions, 16 of which served to validate the mapping IOM Iraq carried out and to gather new information for the mapping.
  - o In December 2020, relevant responses were entered into the mapping to create Version 4 of the mapping spreadsheet (including an additional seven OPDs that IOM Iraq identified through the rapid consultation).
6. In January 2021, IOM Iraq used Version 4 of the mapping spreadsheet to draft this OPD directory and check contact details again.
7. IADO reviewed the OPD directory prior to publication.
8. March 2021, the Directory: Organizations of persons with disabilities in Iraq was released and hosted on IOM Iraq website.
9. June 2021, internal mapping spreadsheet was finalized.
10. October 2021, second version of OPD Directory was released on IOM Iraq website.

Note: IOM Iraq has carried out more extensive mapping on OPDs than what is listed in this directory, including mapping the following for over 50 OPDs in 18 governorates:

- The theme and core activities of the OPD.
- Estimated numbers members of the OPD.
- If the OPD is registered in Federal Iraq and/or KRG as a CSO.
- If the OPD is a member of IADO.
- If the OPD has funding.
- If the OPD focuses on a specific impairment type or component.
